## E175. Apologies for absence

There were no apologies for absence received.

#### E176. Declarations of interest and dispensations

Cllr Dr Barnard declared a standing interest as a town and borough councillor.

## E177. Minutes of the previous meeting

The minutes of the meeting of 28 March 2017 had been previously circulated to members. It was proposed by Cllr Ms Healy, seconded by Cllr Towle and RESOLVED by members present to approve the minutes of the meeting of 28 March 2017.

#### E178. Matters arising

There were no matters arising from the last meeting.

#### E179. Allotments

Members were updated on matters discussed at the Allotment Sub-committee that met ahead of the committee meeting.

Members were advised that the site had been cleared and fenced, with the path and car park to be laid in the following weeks. It was agreed that the scope of the works would need to include breaking up of the clay area of the site.

The Clerk had updated the sub-committee that he was seeking advice from Bracknell Forest Council to ensure the planning application that would be considered under reserved matters.

The Admin team in the Parish Office provided an update on the waiting list. There were 145 persons on the 'raw data' waiting list. Following checks 89 persons were confirmed as living within Warfield, 7 had not address details and could not be checked and 49 persons were identified as no longer within Warfield. The Admin team contacted the 89 persons identified as living with Warfield and 44 had confirmed an interest in an allotment plot, with 10 responding that they were not interested. It was agreed that positive responses would progress to the 'active' waiting list while those who had not responded would be held on an 'inactive' list. This list would maintain their details in case they responded positively in future.

The committee considered the draft Allotment Allocation Policy. Members agreed that an addition should be added to point 2 making it the responsibility of applicants to update their personal and contact details.

Cllr Ms Healy advised members that volunteer numbers for the event were increasing, but more were still required.
