E211. Allotments update

Members were updated on matters discussed at the Allotment Sub-committee prior to the Environment Committee meeting by Cllr Fitzwilliams.

The planning application for the site has been submitted for consideration under reserved matters. The appointment of a contractor for marking out will be sought.

The Clerk provided members with an update on the proposed Frost Folly works. The proposal is to apply a resin-bonded gravel surface across the area. Members were asked to consider the colour of the product and proposed two colour options, one for the car park and one for the remainder of the site. Members selected Brittany Bronze and Silver as their preferred options. scope of the consultation the Clerk would feed this back to the Parks & Countryside team.
